

Appendix B: Contract Clauses, By Province And By Newspaper

Legend:

- Byline credit: any contract clause that mentions journalists' (reporters or photographers) right to withdraw their bylines or photo credits.
- Rewrite consult: any contract clause that mentions consultation with journalists in the event of changes made to their stories or pictures.
- Correct consult: any contract clause that mentions prior consultation with journalists over their work in the event of a correction or retraction.
- Letter consult: any contract clause that mentions consultation with journalists in the event their work or their reputation is criticized in a letter to the editor.
- Express ethics: any contract clause that mentions that journalists may express ethical concerns to their superiors.
- Protect sources: any contract clause that mentions the protection of story sources.
- Ads: any contract clause that mentions journalists' relations with advertising
- No falsehood: any contract clause that mentions that employees will not be required to write, process or prepare anything for publication in a way that distorts any facts or creates an impression the employee knows to be false.
